#### **POSITION SUMMARY**

Ontario Health is seeking expressions of interest from laboratory medicine professionals for the position of **Clinical Lead, Ontario Laboratory Medicine Program (OLMP) – Point of Care Testing**. This is a unique opportunity to provide leadership to drive quality, accountability, and innovation in the laboratory medicine health system. This opportunity is open to all qualified candidates.

The Ontario Laboratory Medicine Program (OLMP) will build upon the framework of the COVID-19 testing network, and with support from the Ministry of Health, will provide strategic and operational coordination and oversight for lab services across the province.

With over 250 million laboratory tests performed in Ontario each year, the OLMP's vision is to enable an integrated testing program across the health system, with laboratory medicine services that are patient-centred, innovative, and ultimately enable the greatest clinical and public health value.

The OLMP's scope of work includes monitoring specimen collection and equitable testing access, leveraging expert advice for appropriate and coordinated laboratory tests, fostering innovation and system responsiveness, enabling digital integration across the testing continuum, and working strategically with health system partners to support point-of-care testing.

The Clinical Lead, OLMP – Point of Care Testing will be responsible for providing strategic leadership to the Point of Care Testing Expert Panel. This includes engaging the Expert Panel and the OLMP Advisory Committee to support the development, implementation, and evaluation of strategic and operational priorities, together as part of the OH OLMP team, required for integration and transformation of health care services for improved clinical care.

### 1. Develop, plan, and implement Provincial Laboratory Medicine program initiatives

- Participate in the recruitment and supervision of Point of Care Testing Expert Panel members and foster their success in this role.
- Represent the Point of Care Testing Expert Panel as part of the Ontario Laboratory Medicine Program's Oversight Committee.
- Facilitate and conduct Point of Care Testing Expert Panel meetings, enabling engagement to provide expertise and feedback on system optimization and delivery of provincial program priorities.

### 2. Advance knowledge transfer and exchange

- Perform evidence review, assessment, and provide recommendations for tests and laboratory initiatives, including reviewing input from stakeholders and considering the economic impact of testing.

### 3. Support system performance and programmatic operations

- Provide leadership towards system performance management, as it pertains to the Program.

### 4. Enable collaboration and system integration

- Strong collaboration with other programs and initiatives related to Laboratory Medicine.
- Participate as an active member of the OLMP Advisory Committee and work collaboratively with other laboratory medicine expert panel clinical leads.
- Establish and maintain effective links with relevant clinical communities on behalf of OH.
- Provide timely advice in response to Ministry, and other requests for information related to the program.
- Support and advance collaboration among stakeholders.

## QUALIFICATIONS

- Clinician within Ontario with five to seven years of experience in Point of Care Testing.
- Proven track record of clinical leadership within health care and/or academic institutions.
- Knowledge of clinical, administrative and system issues with respect to Point of Care Testing in Ontario.
- A professional leadership role focused on quality improvement.
- Aptitude for systems thinking, ability to analyze information and to make sound decisions.
- Enthusiasm for, commitment to, and experience with quality improvement in health care.
- Excellent interpersonal and communication skills with ability to build consensus.
- Highly developed time management skills and ability to prioritize.
- Clinical, research and teaching experience in Point of Care Testing is an asset.
- Hands-on experience with point of care testing program implementation at a provincial level.
