- A minimum of five years of clinical experience in emergency medicine
- Experience in a leadership role focused on quality and system improvement
- In-depth understanding of Ontario's health care system, with particular focus on the challenges and issues facing emergency medicine in rural Ontario
- Expert knowledge of current best practices, healthcare literature, and evidence-based guidelines, as it pertains to emergency medicine
- Knowledge of health system performance measurement and management approaches, and how this can be used as a tool to promote change
- Aptitude for system thinking and ability to analyse information for sound decision making
- Demonstrated commitment to equitable and person-centred care, as well as public accountability
- Excellent skills in relationship building, communication and leadership experience in establishing strong relationships and building consensus with diverse partners and groups
- Demonstrated experience in implementation of large-scale change in the health sector
