POSITION SUMMARY

Ontario Health is seeking expressions of interest for the position of **Clinical Lead (Cancer), Provincial Drug Reimbursement Programs (PDRP)**. This is an opportunity to play a significant role in advising PDRP on operational and strategic issues related to cancer drug reimbursement, and to advance work to evaluate the real-world effectiveness of funded cancer therapies. This opportunity is open to all qualified candidates.

The PDRP unit administers several funding programs for high-cost drugs and services on behalf of the Ontario Ministry of Health (ministry). As part of the Clinical Institutes and Quality Programs (CIQP) portfolio, PDRP provides timely access to high-cost treatments and services, while ensuring the rational use of limited health resources. PDRP's cancer-related responsibilities include administration of the New Drug Funding Program, the High Cost Therapy Funding Program, the Evidence-Building Program and the Case-by-Case Review Program. PDRP also supports the ministry in administering its Out-of-Country prior approval program. PDRP adjudicates funding requests for CAR T-cell therapy, offers an Evidence Search and Review Service, and is the home of the Canadian Cancer Real-World Evaluation (CCRE) Platform, a Core Network Partner of the Canadian Agency for Drugs and Technologies in Health (CADTH)'s post-marketing drug evaluation program, CoLab.

ACCOUNTABILITIES

The key responsibilities of this role are:

- Work collaboratively with PDRP to identify research projects that evaluate access, equity, effectiveness, and value of funded systemic therapies.
- Assist in the identification of research questions; provide clinical insight during methods development and data analysis; and review manuscripts for publication.
- Research projects should be relevant to drug-funding decision-makers and be performed in an efficient and timely manner to address pressing inquiries and explore topics of interest.
- Identify opportunities to collaborate with other Ontario Cancer leads on research projects of interest, and liaise with pan-Canadian and provincial partners on relevant projects.
- Provide oversight of Drug Advisory Committee activities that support drug reimbursement, which include proactive scanning of drug issues, liaising with relevant stakeholders, and developing submissions or proposals for Ministry consideration.
- Provide clinical input and advice to support the daily operations of PDRP related to individual case adjudication, and [clinical trial assessments](#).
- Participate, as requested, on ministry and Ontario Health reimbursement program advisory committees and internal/external working groups.
- Lead and participate in internal and external clinical presentations, as required, on behalf of PDRP.
- Act as an Ontario Health spokesperson on media and stakeholder inquiries related to cancer drug reimbursement, as required.

QUALIFICATIONS

- A medical oncologist or hematologist currently practising in Ontario with a minimum of 5 years of clinical experience.
- Background in clinical trials methodology and clinical epidemiology.
- Recognized as an opinion leader within the oncology community.
- An understanding of drug regulatory approval and health technology assessment processes in Canada.
- An understanding of provincial public drug reimbursement programs for cancer and non-cancer drugs.
- Enthusiasm for, and commitment to, quality improvement in cancer care at the system level.
- Established research track record with relevant past publications.
- Familiarity with, and experience working with, Ontario cancer administrative data sets.
- Track record of developing collaborative research networks and securing external research funding.
- Good understanding of the evolution of “personalized” cancer therapies and their potential impact on cancer reimbursement policies and programs.
- Demonstrate a collaborative leadership model with excellent interpersonal skills and the ability to work effectively with diverse groups of clinicians, as well as individual senior and junior staff.
- Ability to create strong rapport and collaborative working relationships that are built on trust and respect.
- Highly experienced in facilitating effective meetings and building consensus among diverse groups of stakeholders.
- Demonstrated commitment to patient-focused care and public accountability.
- Exceptional written and oral communication skills.
- A background in pharmacoeconomics would be an asset.
- Media training would be an asset.
- Able to commit one day/week to the outlined role for a term of 24 months.
